Violence. Our staff joined the movement by wearing orange







Dawn Center continued to provide excellent service to survivors of domestic and sexual violence and their children in Hernando County, but our Florida Legislature has been hard at work passing new laws that will support survivors for years to come. Some of this new legislation will take effect July 1 and others on October 1 of 2015. Some of the exciting changes include Florida's first law making it a criminal offense for someone to install a tracking device or application on another person's property without their consent, extension of the statute of limitations for certain sexual offenses to eight years, enhancement of criminal penalties related to human trafficking, and Florida's first law that criminalizes sexual cyber-harassment such as distributing explicit photographs of someone online without their consent. Those of us at Dawn Center would like to thank the members of the Legislature for their commitment to survivors of domestic and sexual violence and their children. These new and strengthened laws will provide much needed relief for survivors as they rebuild their lives. We are proud to live in a state who takes these issues seriously and takes action to protect our citizens!
